【Special benefit for supporting child-rearing families】

Given the rise in prices, in order to support child-rearing families, the benefit of 50,000 yen per child is provided with an income limit. Please look at the city website for details and the application form.

	Target	Application
1	Recipients of the child-rearing allowance of April, 2022 have already been paid the benefit	do not need to apply
2	Those who did not receive the child-rearing allowance of April, 2022 at all because they received the public pension(※1,※3)	need to apply
3	People with decreased income which fulfills the child-rearing allowance recipient qualifications due to the Corona virus pandemic(※2,※3)	need to apply

※1.The income of 2020 was lower than the base amount stated in the child-rearing allowance recipient qualifications.

※2.The monthly income after the sudden decrease multiplied by 12 is below the base amount.

※3.If the income of each family member is below the base amount on the list, it is possible to apply.

★Be sure to check this information out if you are a single-parent and have not received the child-rearing allowance of April, 2022, being a recipient of the public pension or you have decreased income which fulfills the recipient qualifications due to the Corona virus pandemic.

1	Qualified recipients of child-rearing allowance or special child dependency allowance from April	Qualified recipients, who are exempt from the equally distributed resident tax of 2022 fiscal year	do not need to apply (※ 4)
2	Those who rear only high school students	Those who had sudden income decrease after January, 2022 due to the Corona virus pandemic (※ 7)	need to apply (※ 5)
3	Those who have either of the rearing conditions listed above (1 or 2)(※ 6)		need to apply (※ 5)

- ※ 4 Even if the resident tax declaration is not finished yet, when the exemption of the equally distributed resident tax is certified after the declaration, it is not necessary to apply.
- ※ 5 The person who earns the highest income in the family is the applicant.
- ※ 6 Those who do not receive the child-rearing allowance or special child dependency allowance because of the income of 2021 can apply.
- ※ 7 The monthly income after the sudden decrease multiplied by 12 should be below the base amount.

★Be sure to check this information out if you are not a single-parent but exempt from resident tax and rear only high school students or you have been exempt from resident tax since January, 2022 due to the Corona virus pandemic.

【Submission of the status quo report for child-rearing allowance】

The qualification for the child-rearing allowance is certified based on the data as of August 1 and the amount from November on is determined. Read the notice carefully and submit the necessary documents.

Target: Qualified applicants who have received the notice from the city, including those who do not currently receive the allowance

Necessary items: Documents stated in the notice

※If the documents are not submitted on time, you cannot receive the allowance or you will lose the qualification.

【Reduction of national health insurance premiums for the involuntarily unemployed】

Target: People, aged 64 or younger, who receive employment insurance benefits following unemployment due to bankruptcy, layoff or termination of employment contract

Necessary items for application: Certificate of employment insurance recipient, personal seal, national health insurance card

Place of application: National Health Insurance Window
